A New Start for the Eastern Centre Gazette Chris Keeble - Chairman

The printed paper version of the Eastern Centre Gazette was first published in 1947 and was circulated through affiliated clubs to their members as one of few methods of distributing information regarding our sport.

For many years the only way that competitors could enter for events was by purchasing the Gazette which contained the supplementary regulations for forthcoming events together with entry forms, filling in a form and sending it by post to the organising club; at one time there was much controversy when some people attempted to enter events using photocopies of entry forms rather than pages torn from the magazine

In 2014 the Gazette was also made available free of charge on the Eastern Centre web site.

During its lifetime the format of the Gazette has changed dramatically from a simple publication printed in black and white to the current full colour magazine of which the Centre should be very proud.

With the advent of electronic communications, social media and the ACU Sport 80 system the role of the Gazette as a means of communicating information has become less relevant.

Regrettably therefore this edition of the Gazette will be the last one in its current paper format

However this gives an excellent opportunity for a reincarnation of the Gazette which will be published monthly and be the mouthpiece of ACU Eastern and its clubs

The new electronic version of the Gazette will be available to everybody free of charge regardless of whether they are members of ACU Eastern clubs or simply interested in our sport and will be delivered directly into their email inbox.

It is intended to have the existing mix of official announcements, articles, announcements of events and advertisements plus input from clubs or individual members

At present there are over 500 members who have signed up for the news alert system that is part of the ACU Eastern web site and, these people will automatically receive the new electronic Gazette. All other people will shortly be able to subscribe for free at www.easternacu.org.

It would be remiss not to record our thanks here, to all of the people who have been involved in the producing the magazine over the years and to Paul Sewter, the last editor of the paper editions who has been very active in adapting the publication to its new format.

I hope that the membership will support the new electronic Gazette in the same way that generations of people supported the paper editions.

An "Old School" Secretary and Sport 80

When I took on the job of Secretary of Lowestoft Invaders MCC in 1970 my first job at the beginning of a New Year was to list in triplicate the members of the club. One copy went to the Centre Secretary and the second to the ACU accompanied by a cheque to cover the affiliation of the members at £1 per head. I'm told that this was increased later but I don't remember that. In those days a typical cheque would have been about £120.

Then some lunatic at the ACU introduced a "sliding scale" of fees which exists to this day. For our present-day membership of 50 we pay a miserly £10 and a club of 100 members pays £20. Think of all the revenue lost to the ACU in the meantime and the ACU "had no money". Sport 80 was thus visited on us. In November 2022 the ACU announced that their website had been moved to a platform called Sport 80 which was "a world-renowned provider of sports management systems" though nobody had ever heard of it. Further: "The new ACU Members system uses future proof technology that is fully supported, user-friendly, and brings new administrative efficiencies". I question this.

The ACU also announced at the same time that there would be "small" increases in the cost of Competition licences and Trial Registrations. Small increases they were not. Licences increased to £70 (an increase of 33%) and Trial Registrations to £20 (100%). For 2025 there will be further increases.

I must admit that I had difficulties in dealing with Sport 80 as Secretary of the Meeting for our events-these difficulties were mainly due to the terminology used as I take the words used to mean what I understood them to mean as an "old school" scholar. In fact I believe that software so-called engineers are illiterate. Anyway, I have had more aggravation in the last 2 years than I had in the previous 50. As Secretary of the Meeting at our events I need to obtain information from the entries list given by the Sport 80 system for the purposes of allocating riding numbers etc.in short; for the administration of the event. In this the initial system worked quite well. The entry list gave the riders details and entries were listed as either "approved" or "awaiting approval" so new entries could be noted. Then the system was changed.

At present entries are listed on pages containing 20 entries but stupidly in alphabetical order. To whose benefit is this? As far as I am aware no discipline starts riders in alphabetical order and as entries are received daily the lists constantly change and this makes it difficult to find new entries. Unless I have missed a trick the only recourse is to note the given total of entries and scroll through the pages in the hope of recognising new names. The total number is not always reliable. Our trial in August listed youth rider Leo Piggott's entry as "complete" to be followed immediately by Leo Piggott's entry as "incomplete". This was counted as 2 entries although it is obviously the same boy and the situation was caused by mother receiving no confirmation of his first entry. It would be more helpful if entries were listed chronologically so that later entries are at the bottom of the page. A puzzling matter is some riders being listed as "unaffiliated" where my understanding is that club membership is a pre-requisite to having a Licence or Trial Registration .

My other dealing with Sport 80 is applying for a permit as I leave the setting up of the online entry for our events to my colleague Thomas Jones. In applying for a permit I resent having to give dates a**e about face and how ridiculous is it to give opening and closing dates and times to the nearest minute? There are no cities in Suffolk so I resent having to type in Lowestoft in the "required field" of "city" in order for the system to work. This should be removed as it requires me to type in what is essentially a falsehood.

ACU Eastern Enduro Championships - Final Round

Sunday 17 November saw Diss MCC run the Muntjac Enduro, the final round of the 2024 ACU Eastern Enduro Championship. Sunday's weather was perfect with the forest tracks drier than for many years. The event is always popular with a full 200 entries again this year. Alex Snow

The first championship riders were away at 9:00am riding a short loop through the forest to the first special test of the day. With 28 championship riders, including top British as well as centre

championship riders all eyes were on the timing screens to see who would lead the pack. As the dust settled it was Alex Snow, Alex Snow Off Road GasGas, who was the only rider under 4 minutes, by a mere 2/100 second. He was closely followed by Sam Hughes, 250 FIR KTM, 9/100 second back with multiple world enduro champion Steve Holcombe in third just a quarter of a second behind Hughes. Ben Cole, 450 GH Mcs Husqvarna made a strong start slotting in fourth, just half a second behind Holcombe followed by Charlie Chater, 250 Yamaha Off Road Experience Yam rounding out the top five, with less than 3 seconds separating the top five. Cole's ACUE Championship rival, Luke Parker, 450 RWT/Matt Pope Kawasaki made a small but costly mistake and was ninth on the leaderboard, some 9 seconds down on Snow.

An hour later the championship riders were back to find a well run-in test and Holcombe topped the times with a 3 minute 46 time, some 14 seconds guicker than test one. However, Snow was not going to let Holcombe out of his sights and he clocked 3 minutes 49 to remain in contention. Parker showed his true speed clocking in third, four seconds behind Snow. Eastern Centre MX champion, Sam Nunn, 450 John Banks Honda, having walked the test multiple times before the start, showed great form slotting in fourth followed by Sam Hughes with six seconds covering the top five. Cole made a small mistake right near the end of this test slotting in seventh, but still almost 3 seconds ahead of Parker over the two tests.

Lap three saw the top three order repeated. Holcombe 1.4 seconds ahead of Snow with Parker 4 seconds behind Snow. Sam Hughes was three quarters of a second behind Parker with Cole a second and a half behind Hughes. Parker was now half a second behind Cole and the battle for the centre championship was intensifying.

For their fourth lap championship riders would face 2 back-to-back tests and the support crews were out in force to catch the action. This time Snow got the best run just a quarter of a second ahead of Holcombe. Parker maintained his form slotting in third, six seconds behind Holcombe with Sam Hughes a second back and Nunn two seconds behind Hughes. Cole again slotted in seventh. Parker was now five seconds ahead of Cole. The final test would be critical for both riders.

Test five saw Holcombe blitz the opposition, posting a 3 minute 44, over 11 seconds up on Sam Nunn with Snow nearly 2.5 seconds behind. Former British MX star Jake Nicholls, 400 Honda showed his speed, 0.7 seconds behind Snow. Ben Clark, 300 Beta UK was the best of the local championship runners in fifth, 1.5 seconds behind Nicholls.

After the five tests Holcombe was nearly 18 seconds ahead of Snow, and Sam Hughes was third, twenty seconds behind Snow with Nunn in fourth, 3 seconds down on Hughes.

So where were the Eastern Centre Championship contenders? On this final test, Cole slotted in seventh, but Parker again had an issue, stalling on the test, dropping him to ninth. Crucially this meant Cole was nearly 3 seconds ahead, Cole in fifth and Parker sixth overall.

The championship riders still had two laps of the course to complete with a last lap allowance of 33 minutes. The event was riding faster than clerk of the course, Andy Waters anticipated, and four riders clocked in 2 minutes early, Snow, Sam Hughes, Ben Clark and Sam Boyd with a further 10 riders a minute early. However, Holcombe had a brake issue and had to retire on his last lap meaning Alex Snow took the victory from Sam Hughes and Sam Nunn with Cole in fourth and Parker fifth.

Ben Cole, 450 GH Mcs Husqvarna had secured his first ACU Eastern Enduro Championship victory and with support crews gathered around, he celebrated with a beer!!! Multiple ACUE Enduro Champion Luke Parker slotted in second and third went to Ben Clark followed by rising stars, Jake Roper in fourth and Joe Phillips in fifth.





In the Expert Vets again the tests decided the overall results with James Jackman, 450 Motoward RFX Yamaha taking victory by just under 4 seconds from Andrew Lawton with Tim Warnes, 250 RWT/Matt Pope Kawasaki, finishing third and best East Anglian some six seconds back from Lawton. Phil Roper 350 ID Decals/Indigo Ross KTM finished fifth giving him the unofficial ACUE Expert Vets Championship win.

In the Clubman class Kit Szabo 250 Carbon Coms KTM riding for Croydon MC was the overall winner and was fastest on both tests. He was followed by young East Anglian Stanly Delany 250 Blackwell GasGas with Alex Christopher, 450 SDG KTM in third.

Despite not being old enough to ride the long course Santon and Muntjac forest events, unofficially Ed Belton is the ACUE Clubman Champion with three wins at the previous championship rounds

In the Clubman Veteran class Raymond Otoka 200 Bikeshed Beta, riding for Diss MCC took the win by a second and a half from Spencer



Newland 350 HMS KTM with Scott Chaplin 350 JC CRT GasGas in third securing the centre Clubman Vet Championship.

Finally, in the ever-popular Clubman Super Vets with an entry of 43 riders, John Hilton, 300 Fab Weld KTM again dominated the class winning by over 17 seconds and again winning the Centre Championship for the Super Vets. Darren Osborne, 249 Crescent/GYTR Yamaha was second, some 17 seconds back with Gareth Lodge, 250 KTM in third.

Thanks to the ever-enthusiastic Diss MCC organising team led by Andy Waters, the Muntjac was again a very successful event and made a fitting end to the ACU Eastern Championship for 2024. As ever we need to thank GH Motorcycles and G+B Finch for supporting the event and GH Motorcycles/Husqvarna for sponsoring the centre championship. Also, thanks to iD Decals for providing the riding numbers for the Championship series. Finally, thanks to Forestry England for our continued use of the forest, and of course to everyone that helped and supported the event. I'm sure Gavin Hockey and the GH team will have been pleased to see Ben Cole their GH man win the centre championship this year. Congratulations must go to all the winners.

Last but not least, don't forget Diss MCC's Santon Enduro set for 23 February 2025. As ever this event is rideable in any condition and is likely to fill up fast – so don't miss out. The 2025 season will soon be upon us.








Motocross Reserved Number Scheme

Renewals Only - available from Noon on Monday 2nd Dec.

Now is the time to renew your number for 2025. If you want to ensure you keep the same number for the 2025 season, you must renew it by 31st January 2025 at the latest. **NO NUMBERS WILL BE HELD AFTER THIS DATE.**

Any numbers not renewed by 31st January will be made available on a first come, first served basis. If you have not renewed your number by this date, there is every possibility that you could lose it to another rider. There were about 700 numbers sold in each of the last 5 years so if you don't want to lose your number, renew it NOW.

You can renew your number online at www.easternacu.org

In the past 8 years diesel, petrol and beer have all risen by over 30%, but cost of reserving your number for 2025 remains unchanged at Σ 5.50 per season. This ensures that the chosen charities (East Anglian Air Ambulance, Essex Air Ambulance & ACU Benevolent Fund) receive just over Σ 5 per transaction.

Numbers 1 –20 are kept for experts only. Number 1 is reserved for the Centre Champion.

Since its introduction this scheme has enabled the ACU Eastern, on behalf of riders, to make donations of more than £40,000 to the chosen charities.

EXPERT NATIONAL / BRITISH CHAMPIONSHIP RIDERS ONLY

Any expert graded rider who is registered for an ACU National Motocross Championship may, where able to do so, purchase their registered number - even if it has already been purchased by a junior graded rider. If you wish to take up this option, please contact the reserved number co-ordinator direct: 07766 904655 – DO NOT attempt to do it online. The timing system will correctly calculate championship points and positions where riders compete in separate classes (expert / junior)

A big thank you to all Eastern Centre Motocross riders for purchasing a number for the 2024 season.

Recollection Section

Sidge Kenny

The first Eastern Centre Gazette was published on the 1st of July 1947. This was barely a year after the reformation of the Eastern Centre, with just 11 clubs, following the end of the Second World War. The man behind the Centre publishing its own journal specifically to greater unify the clubs and invite correspondence and information between them, was the then Centre Chairman: Frank Collins, who represented the Norwich Vikings club and had been a senior Centre official before the War. As ever with such

projects, there was the question of initial costs in getting the journal out to hopefully attract more clubs to rejoin the ACU and the Centre However, there was just over £11:00 in the Centre's entire funds and Frank had his detractors over the idea. Nonetheless he convinced the Board it was worth having a go and see what the reaction would be. They agreed to issue the new Gazette at a "temporary" price of 3p per copy – about the same price of a newspaper. To begin with, the response was enthusiastic, giving the journal a full content, including a 'first hand' - if rather late! - report from the International Six-Days Trial (now Enduro) held in Germany before the outbreak of the War in 1939 and six - more recent - club introductions with their news. Results from the May 1947, "scramble" (Motocross) meeting at Wakes Colne, was also featured and old-timers like me will remember Monty Banks, who was runner up in both the Junior (350cc) and 'All-Comers' races.

Just as in today's Gazette, forthcoming events were featured as well as an introductory Editorial from Frank Collins himself, who hoped the journal would "take off.". As was to be expected in a completely new enterprise, there were no dealers – or anyone else's – adverts though oddly, there was one: "small advert", at one old penny a word, from a Mr Fawkes, who was looking for a 3.50 x 19 rear tyre.. The Ipswich club also took a larger space to advertise their coming: "Motorcycle Grand National" scramble for early August :- "On the finest and fastest Scramble Course in the Eastern Counties!" The actual venue was not mentioned but surely, that had to be Shrubland Park.

The initial response from the small but ever growing batch of Eastern Centre clubs was encouraging and reports and articles as well as the money-making adverts, came rolling in. It should be understood that for a period after the War, petrol rationing was still in place and to add to club difficulties, the ACU, the same year, imposed a 2.5% levy on all events where money was taken from the public. i.e. entrance to meetings, programmes and car parking.. This affected clubs running scrambles (motocross) and grass track events most particularly. The levy came under critical comment by the Centre clubs – one has to wonder, "What's new?"

Frank Collins having proved that an Eastern Centre journal could be a valuable asset to the Centre, stood down as Editor in 1951. He had served the sport as a whole for over twenty-five years and seemingly left a vibrant journal.

Nevertheless, rising costs of production and distribution began to put a strain on Centre finances which gave the subsequent Editor: Keith Bullock, of the Maldon club, a headache right from the start. By then the circulation of the Gazette had reached over 1100 copies per month but the losses were around £12:00 per month which dragged seriously on the

Centre finances of just under £200 for the full year. An interesting statistic is the stamps needed to send out those 1100 copies cost around: £1/15d (£1:75) The losses increased the following year and by now, the Gazette – which everyone loved - but no one evidently wanted to pay for, was under a large shadow.

The Gazette shortfall increased to such a state that the Centre Board decided in April 1956, to cease its publication. However, a Mr Holroyd of the Ipswich club, had the perhaps obvious



idea of making it compulsory for every sporting entry form to be published in the Gazette. Yet, this was unbelievably voted down - and it was not until April 1961 that the Gazette re-appeared - complete with sporting events entry forms. The little ruse promptly generated the essential sales to the ever growing list of Competition riders. Nonetheless, the Gazette had its ups and downs financially and it was not until the 2000's that it sold sufficient numbers with consistent advertisers to make creditable profits. Several editors came and went and I put a list of honour below in respect to them all.

Our Centre Gazette came from being a worrying loss-maker to eventually generating tens of thousands of Pounds. Over time, Electronic media has risen up to take dominance in our communications and for a while the Gazette actually financed that – to such an extent that it has again suffered financially itself. Like a big greedy cuckoo, it is indeed the media upstart which will now survive, though I suggest the best days of the Eastern Centre and possibly motorcycle sport itself, were chronicled by the printed Eastern Centre Gazette. Nonetheless at the recent Centre AGM and Board meeting, it was decided the Gazette should cease in its printed form after an over 70 year span. Sad perhaps - but times move on....

Although I first became a member of the Norwich Viking MCC back in 1973, and have been webmaster of the Centre's website for approximately 20 years, I was first involved in the production of the Eastern Centre Gazette due to the closure of Printing Services (Norwich) Ltd. If my memory serves me correctly (which is not necessarily a given) it was early this century that Eric Potter closed his doors for the last time, and Colin Armes began the search for a new printer capable of handling the onerous task of getting the gazette into print on time every month. I reminded him that ex-road-race marshal and motorcycle enthusiast, Simon Laskey, had started his own print business, and the long association between the Centre and Catton Print began. Little did I know at the time that within a few years I would be sitting at a desk in Catton Print, preparing the Gazette for production from Colin's files.

When illness prevented Colin from sitting at the computer to edit the Gazette I stepped in 'temporarily" to help him out, with him remaining as the Editor. Unfortunately Colin did not recover, and following his sad passing the mantle of Editor was taken on by his son, former Centre Chairman, Phil, with me continuing to prepare the artwork for print.

The growth of digital printing meant it soon became cheaper to print in full colour on digital presses than conventional litho printing in mono, and so it was that in January 2020 the first ever full colour Eastern Centre Gazette, complete with a tribute to the recently- departed Dennis Slaughter OBE, was printed. The bright new future we had planned for the Gazette was brought to an abrupt halt by the Covid-19 lockdown. Despite a drastically reduced calendar, the Gazette still dropped on subscribers' doormats, albeit bi-monthly. Once events began to run again we set about trying to build it into a publication the Centre could be proud of. The new full-colour format was met with much enthusiasm, and a regular flow of photos and reports of events, both past and present, began to be received, as monthly publication resumed.

The decision by the ACU Head Office to enforce clubs to get their permits direct via the newly-introduced Sport80, and competitors to enter events via the same system, negated the requirement for riders to use the printed regs and forms in the Gazette to secure entries for events. It was suggested that this sounded the death-knell for the Gazette and, after a few of the larger clubs ceased to offer it to their members, this became a self-fulfilling prophecy.

Perhaps because of the work I had put into the Gazette, my belief in it as an important historical record of events in the

Centre, and a large part of my working life spent in design for print, I felt it had to continue. I knew there were many people who had given years of service to the Centre and, now not as active as they once were, looked forward to their monthly read. The end of the Gazette? Not on my watch!

However, it seems that the Gazette was not the only casualty of the ACU reorganisation. The loyalty (or perhaps, dependence) of the Clubs on the Centre seems to have quickly dissipated. Where not so long ago candidates had to be voted onto committees. and a dedicated band of volunteers were ready to take on tasks to ensure the smooth running of the Centre, there now remain and ever-decreasing band of hardy, or perhaps foolish, individuals taking on ever more tasks to try and keep the Centre alive and able to serve the Clubs that make up its membership. Although I resigned from all my roles in the Centre, the lack of anyone coming forward as replacements meant I would be placing an intolerable burden on the few left behind. The Gazette requires a lot of work in a very tight timeframe each month - time which is becoming increasingly difficult to find. I therefore decided that, in order to continue to provide the Centre with a website, and many other admin and design-related tasks, I would have to pass the reigns of the Gazette on to someone else. Unfortunately, as with so many other roles that need filling, nobody was available to take the job on. This means that, at least for the time-being, the Gazette in printed form will cease production. There is still obviously a need for a vehicle that enables the Centre and Clubs to communicate with members. and we are working vary hard to implement this. With the support of the Clubs and membership we CAN keep the Centre alive and ready to support the sport. Without it, I fear the printed Gazette will not be

As I sign off for the final time I feel I must express my thanks to those who have supported me in my role as Editor, and without whose regular contributions the Gazette would have ceased long ago. So thanks in no particular order go to 'Sidge' Kenny, Roger Chaplin, & Paula Day for regular content, Richard Blyth , Andy Waters, Narna Media and other suppliers of the photographs that made the Gazette so much more than just a newsletter. I am also in awe of those who came before. How on earth they managed to get the Gazette out on time, and distributed around the region, in a time before the technologies and transport systems we now enjoy is truly heroic. Mention must also go to the many loyal advertisers, whose financial support enabled the gazette to flourish for many years. Finally, a massive debt of gratitude is owed by the Centre to Ron Greengrass, who handled the advertising sales, finances and distribution of the Gazette for as long as I can remember.


